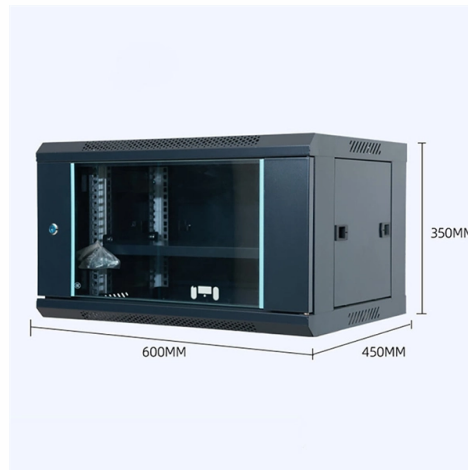


Noise Standards for Telecommunication Towers



Overview

This European Telecommunication Standard (ETS) specifies acoustic noise emission limits for equipment used in telecommunication locations as specified in the ETS 300 019-1 series. 33) Annual Subscription from 1st January, 2011 in Local : #15. These standards provide a comprehensive framework. They are designed to ensure the structural integrity of towers and the safety of all personnel. These set of standards comply with the International Building Code (“IBC”) while providing guidance for the procurement, design parameters, and maintenance and condition assessments of these antenna.
